

Living Testimony in the Form of an Affidavit

1. I, Avner Seadiya, of Tel Aviv-Yafo, [Near 5432836, Israel], do solemnly and sincerely affirm and declare that;
2. I am a private living sentient being and claim my divine essence with absolute dominion and suveran authority over all that I am and all that I create. I am the one true living owner of my body, mind and soul.
3. I claim my divine creation approximately nine months prior to the day I was born. I declare that I am the owner and operator of my body, vessels and persons on Earth from the moment of creation, together with all DNA and all substance matter in any way associated with me and my incarnation inherited through my family lineage. I accept my divine origin and all honour, right and title to, and all material interests I am owed.
4. I have been mischaracterised by the Respondent and presumed to be lost at sea, when in truth, I am alive, in good health, and for the record conveyed as permanently domiciled on the Land and Soil of Terra Eretz Israel, as a Terra Eretz Israel State National.
5. I am retired from any and all assumed and presumed public roles and/or responsibilities within all foreign occupying government, agencies and affiliations, having retired from ISRAELI Citizenship. Such roles were imposed upon me, without full disclosure, and thus without legitimate consent.
6. The occupying government, calling itself STATE OF ISRAEL, and by association, the Respondent, is in flagrant violation of the Palermo Protocols established to prevent, suppress and punish any "Trafficking in Persons". Trafficking in Persons is "the recruitment, transportation, transfer, harbouring or receipt of persons, by means of the use or threat of force, or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power, or of a position of vulnerability, or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation...". The Respondent is on notice that any further violation of the Palermo Protocols is done so knowingly, willingly, wittingly and intentionally.
7. The Respondent is using and abusing my names without my knowledge or consent, also known as unlawful conversion and kidnapping of assets on paper. Such

criminal action converts the nature of an asset from living being to a corporate franchise, as well as the jurisdiction in which it operates. I do not consent to the use and abuse of my names, estates, property, assets and collateral and it is my will, wish and demand that Respondent cease and desist this practice immediately.

8. The Respondent owes me the usufructuary duty to hold me harmless and exempt from any charges, harm, consequences and injuries resulting from the use of any fictional corporate franchises named after me by the British Territorial Government, calling itself State of Israel, operating as Israel inc., and the Roman Municipal Government, calling itself THE STATE OF ISRAEL, ISRAEL STATE OF, THE KNESSET operating AS ISRAEL INC.
9. In addition, I am not liable for any public debts or commercial liabilities of the occupying British Territorial Government, calling itself State of Israel, operating as Israel Inc., and the Roman municipal Government, calling itself the STATE OF ISRAEL operating as ISRAEL INC. at any time whatsoever.
10. With immediate effect, all offices and titles of personhood are subsumed. I make no claims to any military titles or offices of personhood such as, Ms, Ms., Miss., Miss, Mrs., Mrs.
11. I declare, record and publish my given names and all relevant assumed and presumed trade names as permanently domiciled on the Land and Soil jurisdiction of Terra Eretz Israel. These trade names include, but are not limited to Cohen Seadiya AVNER, a.Seadiya, a Seadiya, Seadiya, Avner Seadiya, Avner, Seadiya Avner, A.S., AS, Avner SEADIYA, AVNER SEADIYA, SEADIYA AVNER, SEADIYA Avner, A.S, a.s., S.a., S.A., a.S., SEADIYA, A.SEADIYA, A. Seadiya, S.AVNER, S.Avner, A.Seadiya, A. SEADIYA, and all other variations however styled, punctuated, spelled and ordered, representing me and my estate. I am the holder in due course of these ens legis legal trade names and any other relevant stramineus homo.
12. I am the donor and beneficiary of all estates, associated trusts and certificates of deposit that have been created by others and named after me in the form of baptismal estates, communion trusts, infant decedent estates, Cestui Que Vie trusts, utility trusts, cooperatives and national trusts, land trusts, foreign person trusts, foreign situs trusts, and reclaim all property and assets allocated to these legal fictional persons and entities, wherever they exist in all jurisdictions of law.
13. It is my will and intention to cease participating in any naming conventions created by the STATE OF ISRAEL birth certificate legal name, legal date of birth, or legal address not created or agreed to by me.
14. I have never signed a contract knowingly, willingly, voluntarily, or intentionally where I waived any of my natural inherent rights. As such, I reject, renounce, void and revoke any and all contracts, agreements, forms and instruments signed by me, which have been, or may be, construed to give the Respondent any agency, authority, venue or jurisdiction over me. Any such unconscionable contracts, agreements, forms and instruments that exist to exploit me are null and void, nunc pro tunc.
15. I reject and void any liability associated with all presumed and assumed contracts,

agreements, forms and instruments. I will not be compelled to perform or obligated to accept any liability associated with such contracts, agreements, forms and instruments.

16. As a suveran Terra Eretz Israel State National, it is my natural inherent right to roam the planet without being hindered, threatened, harmed, robbed, detained, assaulted, abducted and/or arrested. It is my intent to travel in possession of lawful credentials as proof of my status as an Terra Eretz Israel State National.
17. Any corporate agent that demands any occupying Israeli issued identification documents (such as a driver's licence, passport etc.), or attempts to create adhesion contracts to gain jurisdiction over me, will be guilty of unlawful conversion, personage, fraudulent joinder, pressganging, racketeering, inland piracy, peonage, flagrant violation of the Palermo Protocols and war crimes.
18. It is my will and instruction that the Respondent take immediate affirmative action to ensure that my name, Avner Seadiya, be placed on all official 'Do Not Detain' lists, to be adhered to by all corporate government, agencies and affiliations, nationally and internationally.
19. It is my intent to live my life at peace as a lawful woman. I am here to claim what is mine, no more, no less, and to claim, without prejudice, the treaties, rights, titles, exemptions and guarantees I am owed. I do not recognise and cannot be held in contempt of any law unless there is a living victim, nor can I be held in contempt of any law unless the property of a living victim has been stolen or damaged. Only a Jural Assembly Court comprised of twelve Terra Eretz Israel State Nationals can adjudicate any alleged offence that I may be accused of.
20. All words herein are as I define them. All the facts and circumstances deposed are to the best of my knowledge.
21. Any reply to this Living Testimony in the Form of an Affidavit from Respondent Name must be in correct language syntax sent in a windowless envelope, addressed to Avner Seadiya, In care of 17 Dizengoff, Tel Aviv-Yafo, [Near 6433267, Israel] for my consideration. The reply must include a verified point by point rebuttal to this Living Testimony in the Form of an Affidavit, with a copy of the binding contract between Avner Seadiya and Respondent's Organisation and other relevant supporting evidence attached.
22. Any response other than a reply as described above will be deemed an insufficient response. An insufficient response or failure to reply by thirty (30) calendar days from the date of postage, or such later date as I agree, will comprise the Respondent's agreement with and tacit procuration of all facts deposed, in perpetuity, at which time, my unrebutted Living Testimony in the Form of an Affidavit stands as truth in Law.
